FINANCIAL ASSISTANCE

Full or partial assistance may be available based on the financial condition of our patients and is determined in accordance with our Charity Care Policy.

A Financial Assistance application is used to determine eligibility. If approved, this program covers medically necessary services provided by the Hospital. Little Company is proud of the doctors who practice here. Some of these doctors may be out of network providers. They are not employees of Little Company and bill separately for their services. Financial Assistance does not apply to private physician bills or other fees a patient may incur.

To be considered for a full or partial discount under our Charity Care Policy, you must provide the information and documentation requested in the application. You must first apply for other existing financial resources that may be available to pay your health care bills such as Medicare, Medicaid, All Kids, Worker’s Compensation and other liability claims.

Please complete the attached application and return it with in 10 days to The Business Office at the address above with all the supporting documentation.

Once the completed application is received, a determination will be made and a written response will be sent to you. If you have any questions or require additional assistance in completing the application, or to request an itemized bill, please call our Patient Accounts Customer Service Department at 708.499.8500.

PAYMENT OPTIONS

For your convenience, we accept all major credit/debit cards and personal checks (with a valid driver’s license or state ID), cash, money order or cashier’s check.

CO-PAYS AND DEDUCTIBLES

Your insurance company may require a patient portion for services rendered. If your insurance policy has a deductible or co-pay amount, we will ask that it be paid prior to service.
